FAO: All Port of Tilbury “Permit to Manoeuvre” Holders and Approved Mooring Contractors

Under the Port Marine Safety Code the Port of Tilbury is required to ensure standards of competence are maintained and part of this requires that we outline present procedures for marine safety within the harbour.

All holders of a ‘Permit to Manoeuvre’ or contractors who are approved to carry out mooring operations within the ports are required under those permits to have a full understanding of the port’s procedures which can be found on the Marine Department website at www.tilbury-marine.co.uk/documents.

**Additionally “GDPR” came in to force in 2018 for the UK.
This relates to personal data and the safe storage of this.
By signing this form you will consenting that you are happy for the Port of Tilbury to retain your personal information on file.
This includes the storage of CCTV and incident report forms for a period of 10 years.
You are also kindly reminded that all telephone calls and VHF calls are recorded and kept within a secure data base.**
