## Scope

The emergency contacts directory will not replace the local port contact lists, which have contact lists of tenant companies and key Forth Ports personnel at each individual port.

Forth and Tay Navigation Service maintain a list of the home numbers of all Forth Ports Limited staff who are nominated to respond to emergency situations including Clearwater Forth, Grangemouth OPRC, Leith OPRC, Dundee OPRC, Emergency Forth and Emergency Tay.
