Forth Ports Limited is the Statutory Harbour Authority for the Port of Grangemouth and the River Forth. This pre-arrival information is to inform you of important safety and environmental information that you will require whilst berthed in the Port of Grangemouth.

Prior to arriving at the Port of Grangemouth, you will require a Port Agent or representative of the vessel to make an application for a berth, lock entry slot and book various marine services (such as pilotage and line-handling etc.) for your vessel.

Forth Ports Limited expect all vessels operating within the Statutory Harbour Authority area to comply with the Code of Safe Working Practices for Merchant Seafarers which can be found here https://www.gov.uk/government/publications/code-of-safe-working-practices-for-merchant-seafarers-2020

We ask that whilst in the Port of Grangemouth, all crew adhere to the Life Saving Rules and all appropriate direction and signage within the port estate.

Ten Key Requirements for **Port of Grangemouth**

The safety and security of all users of the Port of Grangemouth is paramount, so we expect all users of the Port estate to follow the Port's requirements:

1	In the event of an emergency raise the alarm as follows; Emergency Services (Police, Fire, Ambulance) – 999 Forth & Tay Navigation Service (FTNS) via VHF CHANNEL 14 (Call sign "Grangemouth Locks") or by telephone 01324 498584. Ensure you have the following information ready; Who - Name	
	Who - Name What – Details of Incident or event Where – Location / Berth within the Port When - Time of incident or event.	
2	 Security Security is of highest importance, there are a number of restricted areas within the Port of Grangemouth. No person is permitted within the Port of Grangemouth unless on lawful business. Whilst in Port, you and your crew must be extra diligent with security. You are advised to carry out the following: Ensure all ships personnel have available photographic identification as this will be required to gain entry to the Port. All visitors to the Port must be logged with security, providing the visitors name, nature of visit and expected arrival time and they must produce photographic Identification to the local security gate on arrival. Temporary day passes must be obtained from Security Gate Houses for vehicles entering the Port. Young Persons under the age of 16 are not permitted on the Port unless prior approval has been received by Port Manager or Deputy. Contact FTNS for further details or visit Forth Ports website. Never leave visitors or strangers alone on your vessel; ensure you escort them ashore. Maintain a gangway watch at all times. Be suspicious and challenge any suspicious characters or activity and report to FTNS. 	<image/> <image/>

3	Smoking in PortSmoking can only take place in designated places onboard your vessel unless the berth or Jetty operator specifies otherwise.The Port of Grangemouth has a strictly NO SMOKING policy.	
4	 Vessel Maintenance Whilst in Port Painting Painting or chipping over the side of your ship is not permitted whilst in the Port of Grangemouth. Hot Work Consent No hot work or any work that produces a spark, flame or radiated heat is permitted on board your vessel unless you have first received consent for such work to take place from FTNS. To request a hot work permit please completed the form found on the website and send in an e-mail to ETNS@Forthports.co.uk Diving Consent No diving is permitted unless you have first received consent from FTNS. If you require a diving Permit please email the completed form to ETNS@Forthports.co.uk Use of Ships Boats If you require to lower any boat into the water, for any reason such as emergency drills, permission must first be obtained from FTNS, see Contact List for further guidance. Whilst permission may be granted by the Duty Harbour Master, when lowered into the water a boat must always remain within close proximity to your vessel. Any works requiring the use of external contractors must be planned via the local agent to ensure the activities are coordinated through the relevant Port Departments. 	
5	Bunkering OperationsBunkering from shore to ship and barge to ship are the only ways you can take on fuel whilst in the Port of Grangemouth. Please arrange all bunkering through your local agent.Further guidance can be found within the Forth Ports Marine Procedures, Guidelines and Information Document which can be found on the Forth Ports Website. 6	Fresh Water Provision & Black/Grey	
	Water Disposal	
	If you require fresh water for your vessel please request this ideally with 24 hours' notice via Duty Harbour Master on 01324 49 8584 or by VHF channel 14. Fresh water equipment will be provided by the Port. To ensure we maintain the standards of the watering equipment you are asked to ensure that on completion of operations all hoses are arranged in coils and placed on a non- contaminated area of the quay, along with all other equipment on loan for collection. Please inform "Grangemouth Locks" on VHF Channel 14 when equipment is ready for collection. The Company reserves the right to recover any costs resulting from failure to take reasonable care of water supply equipment. Disposal of Black or Grey water must be arranged via local agent.	
7	Port Waste Reception Facilities	
	 Port of Grangemouth provide waste reception facilities for General Waste and International Catering Waste. These facilities are provided to ensure that all vessel generated waste must be disposed of in an environmentally sustainable and legally correct manner. International Food Waste – all food stuffs or items that have been produced whilst travelling outside the EU. This waste requires Category 1 disposal and must be placed in a designated ICW receptacle only. General waste - (e.g. office waste, paper etc.) including recycling such as plastics and cans – these will be separated out at the waste contractor depot. All other wastes must be removed via a port approved licensed waste contractor and organised by the ships agent. Such wastes could include: pallets, oils and oily contaminated materials, paints/paint pots, chemicals, cargo residues (e.g. dunnage), scrap, clinical/medical waste, batteries, sewage. This waste must not be placed on the quayside until waste provider is onsite and must be collected prior to vessels departure. 	
	Charges are made for the waste reception facilities for all vessels – these can be found in the Port Tariff via your local agent.	
	A copy of the approved Port Waste Plan can be found on the <u>Forth ports Website</u> .	

	Annex V of MARPOL has been put into place to minimise the	
	pollution of garbage from ships.	
	The Port of Grangemouth does not tolerate pollution from any hazardous or non-hazardous garbage, whether it is in the water or on the quayside.	
	Persons throwing or emptying garbage into the water or onto the quayside may be liable for prosecution.	
8	Crew on the quayside	
	In the interests of safety, crew must not walk across any operational areas - in particular any container stacking areas when berthed adjacent to an operational area.	
	The operational area of the port is an area of high activity involving many items of heavy plant and equipment. When proceeding ashore all crew must wear high visibility clothing, hard hat and safety boots. Please note that arrangements can be made through your Agents for this equipment to be left at the Security Gate for personnel proceeding on shore leave.	
	Designated pedestrian walkways and exit routes, marked on the port traffic management plan (attached) must be used. Masters are advised that they must ensure that their officers, crew and any passengers are aware of the safe designated walkways around the port marked in yellow, which they must use when walking ashore. In addition all persons within 1 metres of any quayside should wear a suitable buoyancy aid or lifejacket (unless directly embarking or disembarking to or from the gangway).	
	Unauthorised vehicles (e.g. Taxis) are not permitted within operational areas (e.g. Quayside). This includes collections and drops offs. In addition, the riding of bicycles is not permitted within the operational area (e.g. Quayside).	
	Designated Taxi Pick-up/Drop off points are located throughout the Port estate – see Traffic Management Plan within this pack.	
	Please note that the taking of pictures, making of sketches and filming of any part of the Port of Grangemouth estate is prohibited under the Port of Grangemouth Bye-Laws.	
	The Grangemouth Seafarers' Centre is unmanned and open 24 hours, 7 days per week. Location is marked on Port map. Door Access code is C2568Z

9	Safe Means of Access The Merchant Shipping (Means of Access) Regulations are strictly enforced. Failure to comply with these regulations may result in delays to cargo operations until an approved safe means of access has been supplied.	<image/>
10	Eastern Channel Berths	
	For all vessels berthing at a jetty / terminal in the Eastern Channel at Grangemouth please refer to the specific operators own Jetty Regulations / guidance.	
	INEOS - Please ensure you are familiar with the INEOS Jetty Regulations prior to arrival at your berth/Jetty, these can be obtained via your local agent.	
	Common User Oil Jetty (CUOJ) - Please ensure you are familiar with the CUOJ - Jetty Regulations. These can be found on the Forth Ports Website or via your local agent or from FTNS.

LIFE SAVING RULES



Our vision is clear: we are all **one team**, with **one goal** – **to make injury unacceptable in our business**.



Check isolations before starting work; and use lock out/tag out.



Hazards must be identified, communicated and controlled prior to starting work.



Only enter a confined space if you are competent and authorised to do so; always check the atmosphere.



Obey the speed limit, wear a seat belt and don't use a phone when driving or operating machinery



Be aware of how close you are to the water's edge and wear a lifejacket when required



Lifting operations must be planned, supervised and carried out by competent people



Wear your Personal Protective Equipment, and take care to store and maintain it properly.



Protect yourself and others against a fall when working at height.
