

## Marine Environmental Guidelines Forth Ports - Scotland



The table below outlines the environmental regulations for ships operating or transiting within the Firth of Forth, and Firth of Tay

Underwater cleaning of hull.	Not permitted unless growth can be captured and disposed of on land as waste.
Hull painting.	Not permitted in port.
Paint chipping	Not permitted in port. Vessels may chip at anchor or while underway outside of port.
Fuel restrictions	As per <a href="#">MARPOL Annex VI</a> .
Use of incinerators	As per <a href="#">MARPOL Annex VI</a> .
Grey water discharge	Not permitted in enclosed dock. Permitted in tidal waters including the estuary, Crombie, Rosyth and other estuarial marine terminals if the grey water is treated in appropriate plant as per <a href="#">MEPC 227 (64)</a> .
Discharge of garbage	As per <a href="#">MARPOL Annex V</a> . and <a href="#">Merchant Shipping (Prevention of Pollution by Garbage from Ships) Regulations 2020</a> For individual port waste management plans see: <a href="https://www.forthports.co.uk/marine/information/">https://www.forthports.co.uk/marine/information/</a> .
Discharge of treated blackwater/sewage	As Per <a href="#">MARPOL Annex IV</a> , <a href="#">Merchant Shipping (prevention of pollution by sewage and garbage from ships) regulations 2008</a> and <a href="#">2010</a>
Discharge of pool/spa water	Fresh water and salt water discharge permitted only.
Discharge of scrubber water	Any discharge to water is strictly not permitted.
Discharge of commutated food waste	As per <a href="#">MARPOL Annex V</a> . For individual port waste management plans see: <a href="https://www.forthports.co.uk/marine/information/">https://www.forthports.co.uk/marine/information/</a> .
Rinsing of the hull	Fresh or salt water only.
Propeller polishing	Dependent on level and origin of marine growth, and methodology of cleaning. Contact FTNS to request permission.
Discharge of advanced wastewater purification treated blackwater	As per <a href="#">MARPOL Annex IV</a> .
Discharge of ballast water	As per <a href="#">IMO International Convention for the Control and Management of Ship's Ballast Water and Sediments</a> . and <a href="#">Merchant Shipping (Control and Management of Ships' Ballast Water and Sediments)</a> .
Venting/gas freeing	Not permitted in the Forth Ports Statutory Harbour Authority area.
